Referring back to ISCAID guidelines on Urinary Tract Infections are essential for maintaining up to date antimicrobial stewardship practices.






Obesity will cause a decreased quality of life, shorten life span and contribute to numerous co-morbidities that you see on a daily basis.



Taking care of the Microbiome!



Think about this in your most susceptible patients for e.g. puppies and kittens! Antibiotics can cause a prolonged microbiota disruption or dysbiosis in certain patients. It is not possible to predict which patients those are.

Maintaining a healthy microbiome is essential in puppies and kittens. The microbiome supports the normal development of the gut's digestive and absorptive functions, local and systemic immune responses, gut motility as well as impacting behaviour, cognition and metabolism.

Antibiotics can be life saving but should not be considered first line in diarrhea cases unless specifically indicated. Specific antihelmintics should be used including when Giardia is diagnosed as first line therapy. Significant dysbiosis has not been demonstrated with the use of Fenbendazole.
